## **21/1 Welcome from the Vice-Chancellor & Chief Executive**

NOTED:

Kerrie Holland, Director of DARO, provided a 'house-keeping' introduction and briefing on Blackboard Collaborate.

The Vice-Chancellor, Professor Alec Cameron, welcomed members of Convocation.

The Chancellor, Sir John Sunderland, and Pro-Chancellor, Dame Yve Buckland DBE, apologise for their absence; the Vice-Chancellor will chair this meeting. The Vice-Chancellor will present the report from the University and Chief Operating Officer, Neil Scott, will present a financial report on the 2019/2020 University Accounts.

The Vice-Chancellor noted he will be leaving the University at the end of the calendar year to take up a Vice-Chancellorship at RMIT University, citing

personal pull-factors for his return to Australia. It was noted an Executive search for the Vice-Chancellor's successor is underway.

Questions were submitted in advance of this meeting and they will be dealt with in 'Any Other Business'.

## **21/2 Minutes of the Annual General Meeting of Convocation held on Thursday 13<sup>th</sup> August 2020**

AGREED:

It was agreed that the minutes from the previous meeting were true and correct.

The Vice-Chancellor signed the minutes for the Annual General Meeting of Convocation 2020 as a correct record of the proceedings.

## **21/3 Matters arising from the minutes**

Feedback had been sought from members of Convocation who attended AGM's first online meeting in 2020. It was noted Kerrie Holland received positive feedback from two attendees, and two who commented they wanted to attend for the Vice-Chancellor's report and Q&A, but not for the procedural items. It was noted in response to this feedback attendees were invited to join the meeting from 1.10pm if they prefer, with future meetings and invitations to follow the same format and schedule.

It was noted the Shakespeare-Martineau review of Council has been published on the Convocation AGM webpage.

## **21/4 Report from the Vice-Chancellor and Chief Executive**

RECEIVED:

The Vice-Chancellor & Chief Executive presented his report.

NOTED:

It was noted that some questions and comments submitted in advance by members of Convocation were answered in the presentation.

## **21/5 Report from the Chief Financial Officer Report on University Accounts for the Year Ended 31st July 2019 and context of performance in current year**

The 2019/20 University Accounts were posted on the website and a link given at the end of the 2018/19 minutes, which were sent in advance of this AGM.

Neil Scott commented on the status of the University's account:

- 2019/20 was a positive year although the last 3 months were impacted by the Covid-19 pandemic.

- All commercial activities and research stopped during the first national lockdown and a number of staff in these areas were furloughed.
- £15m was drawn down from the revolving credit facility with HSBC to support available cash balances.
- Recruitment has been positive in 2020/21, despite the challenges presented by Covid-19 including:
  - Blended learning
  - Changing travel restrictions
- Adaptability has been key and teams have worked hard to recruit and deal with the changing requirements. The University delivered our largest ever January intake.
- Research continued during the 2<sup>nd</sup> and 3<sup>rd</sup> lockdowns but has been impacted due to lack of travel and conferences meaning income is not forecast to be as high as budgeted.
- Covid-19 has also resulted in an impact on awards for 2020/21 as funding bodies are taking longer to decide on funding. This will impact future years.
- Commercial income has also been impacted due to national lockdowns and government restrictions. However, indications are that bookings are recovering in Conference Aston since restrictions have been lifted.

## **21/6 Matters Arising from the Vice-Chancellor's Report and the Chief Financial Officer's Report**

There were no further questions raised.

## **21/7 Any Other Business**

1. It was noted the Aston Graduates Association prize was not awarded this year as it was felt the nominations were not of the usual high standard, partly due to the restrictions which COVID placed on student activity. The Aston Graduates Association expect to award a prize next year and it will be reported at the 2022 AGM.
2. The University received a question relating to the delivery of Inaugural Lectures by new Professors. (Question raised by Mr David Harrison)

*There seems to have been a break of several years in the presentation of Inaugural Lectures by new Professors from before this pandemic. When will these lectures restart?*

Response from the Vice-Chancellor:

There was no break in the Inaugural Lectures programme, although they are sometimes at irregular intervals due to the speaker's availability. The Inaugural Lectures were rebranded as Aston Talks in 2020 and have been taking place online during the pandemic, with monthly events in term-time until May this year. Attendance has been higher and people can attend from all over the world. We intend to keep going as virtual events therefore, and the 21/22 programme will be launched in the Autumn term.

3. The University received a question in relation to the standard of British English in exam papers rather than the use of US English. (Question raised by Mr David Harrison)

Response from the Vice-Chancellor:

Exam papers are a matter of academic judgement, written by academic staff and signed off by external examiners. We expect our academic staff to use appropriate language and for exam questions to be clearly understandable for the students sitting the examinations.

4. The University received a question in relation to the provision of toilets for female students, particularly during exam times. (Question raised by Mr David Harrison)

Response from the Vice-Chancellor:

A similar question was raised at Convocation AGM in 2018 and I can confirm the answer remains the same:

The question was raised with the Estates team, and they confirmed that there are female toilets and adequate facilities on every floor of the Main Building including the North and South Wings.

The toilets include multiple cubicles, and this has not been raised as an issue by student representatives.

5. A question was received in relation to the University's ranking. (Question raised by Mr Kevin Wong)

*I have a question for the ranking of the university. Why does it keep dropping in the past few years. Does the management team have any plan to improve it?*

Response from the Vice-Chancellor:

As highlighted in the Vice-Chancellor's Report, Aston has had some great league table performance and recognition this year, not least as The Guardian's 'University of the Year'. As a smaller university, we do have additional challenges in global rankings such as the QS World Rankings, to which I think the questioner may be referring given its international significance. 50% of the ranking is derived from reputation – put simply: asking academics and employers around the world which universities they rate highest – and although our academic staff and graduates are extremely well-respected there are fewer of them than in many thousands of other institutions in the world. We were pleased to see a return to the top 500 globally this year, and this continues to be a target for improvement. Alumni who are in academic or graduate employer roles can register with QS to complete the annual reputation survey if they wish.

No other questions were submitted in advance of the meeting.
